A Bill for an Act to authorise the issue from the Consolidated Revenue Fund of the Federation the total sum of **=N= 2,176,791,286,033** (Two Trillion, One Hundred and Seventy-Six Billion, Seven Hundred and Ninety-One Million, Two Hundred and Eighty-Six Thousand, Thirty-Three Naira) only, of which **=N=18,000,000,000** (Eighteen Billion Naira) only is for Statutory Transfers, **=N=992,802,015,985** (Nine Hundred and Ninety-Two Billion, Eight Hundred and Two Million, Fifteen Thousand, Nine Hundred and Eighty-Five Naira) only is for Recurrent (Non-Debt) Expenditure while the sum of **=N=1,165,989,270,049** (One Trillion, One Hundred and Sixty-Five Billion, Nine Hundred and Eighty-Nine Million, Two Hundred and Seventy Thousand, Forty-Nine Naira) only is for contribution to the Development Fund for Capital Expenditure for the year ending on the 31st day of December, 2023.

BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: -		
1	(i) The Accountant-General of the Federation shall, when authorised to do so by Warrants signed by the Minister charged with responsibility for finance, pay out of the Consolidated Revenue Fund of the Federation during the year ending on the 31st day of December 2023, the sums specified by the warrants, not exceeding in the aggregate =N=2,176,791,286,033 (Two Trillion, One Hundred and Seventy-Six Billion, Seven Hundred and Ninety-One Million, Two Hundred and Eighty-Six Thousand, Thirty-Three Naira) only for the year ending on the 31st day of December, 2023. 	(ii) The amount mentioned in subsection (1) of this section shall be appropriated to heads of expenditure as indicated in the Schedule to this Bill	
	(iii) No part of the amount aforesaid shall be released from the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (1) of this section.	
2	All amounts appropriated under this Bill shall be released from the Consolidated Revenue Fund of the Federation only for the purpose specified in the Schedule to this Bill.	Release of funds from the Consolidated Revenue Fund
3	In the event that the implementation of any of the projects intended to be undertaken under this Bill cannot be completed without virement, such virement shall only be effected with the prior approval of the National Assembly.	Virement
