Fiscal Years 1950 – 2024

The fiscal year (FY) 2024 edition of the Historical Sales Book (HSB) provides a by-country and international organization summarization of *the authorized value of implemented transfers of defense articles and services*.¹ This includes Foreign Military Sales (FMS) and FMS cases funded with Foreign Military Financing (FMF) implemented through the FMS system from FY 1950 through FY 2024.

FMS, authorized by the Arms Export Control Act, is the system through which eligible foreign governments and international organizations may purchase defense articles, services, and training from the U.S. Government. The Department of Defense (DoD) leverages the FMS system to execute government-to-government transfers of defense articles or services from current DoD stocks or DoD-managed contracts.

The FY 2024 HSB includes only FMS and FMS funded with FMF, as was done with the FY 2023 edition (available at: <https://www.dsca.mil/Resources/Publications/Publication/Article/4049946/dsca-historical-sales-book>). Editions prior to FY 2023 of the HSB included Building Partner Capacity (BPC) and Foreign Assistance Act (FAA) funded programs. However, with the decoupling of BPC cases from the FMS process, BPC and FAA data will be released later. The FY 2024 HSB retroactively provides FMS and FMS-funded cases with FMF data at the country and organization-level for FY 2020 to FY 2024. The published data is sourced from DSCA’s authoritative data sources or systems of record.

Total Authorized Value of Implemented Transfer of Defense Articles and Services

This section includes an alphabetical list of all countries and international organizations eligible to participate in FMS from 1950 to present. The amounts listed represent the total *authorized value of implemented transfer of defense articles and services* funded by our partners (FMS) and FMS funded with FMF (United States Government). The total *authorized value of implemented transfers of defense articles and services* from FY 1950 through FY 2019 is consolidated in one column. The most recent five FYs identify implemented values for FMS and FMF, and a total column for FY 1950 through FY 2024 is also included.

Column heading descriptions are follows:

- **Country** – This lists the names of every country and international organization that received defense articles, services, and training from the U.S. Government through the FMS system. Some countries and international organizations listed have multiple FMS accounts.
- **Combatant Command** – The DoD delineates areas of responsibility (AORs) to the combatant commands (CCMDs), and each country and organization falls into one of these CCMD AORs. Those organizations not solely dedicated to a particular geographical region are listed as non-regional (NR).
- **State Department Region** – Like the DoD, the State Department divides the world into several regions, and each country and organization falls into one of these regions. Those organizations not solely dedicated to a particular geographical region are listed as NR.

- **Continent** – The continent where each country and organization are located. Organizations without a particular continent are listed as N/A.
- **Fiscal Years 1950 to 2019** – The *authorized value of implemented transfers of defense articles and services* from these years is consolidated into this column.
- **Fiscal Years 2020 to 2024** – The five most recent years of the *authorized value of implemented transfers of defense articles and services* and security cooperation (SC) programs are separated by FMS and FMF.
- **Fiscal Years 1950 to 2024** – A total of every year since 1950.

How the Total Authorized Value of Implemented Transfer of Defense Articles and Service is Calculated.

- Total Authorized Value of Implemented Transfer of Defense Articles and Services are counted in the FY that a Letter of Offer and Acceptance, an Amendment or a Modification is implemented, regardless of the value.
- Occasionally an Amendment or a Modification is implemented with a negative value. These values indicate an adjustment to one or more of previously implemented cases. In some instances, any positive implemented values in the same FY don’t overcome the adjustments. This results in a negative total value for the year.

Glossary of Terms

Arms Export Control Act – The basic U.S. law providing the authority and general rules for the conduct of foreign military sales and commercial sales of defense articles, defense services, and training. The AECA came into existence with the passage of the Foreign Military Sales Act (FMSA) of 1968. An amendment in the International Security Assistance and Arms Export Control Act of 1976 changed the name of FMSA to the AECA.

Arms Transfers – The sale, lease, loan, or other transfer of defense articles and defense services such as arms, ammunition, and implements of war, including components thereof, and the training, manufacturing licenses, technical assistance, and technical data related thereto, provided by the USG under the authority of the Foreign Assistance Act of 1961, as amended, or the Arms Export Control Act, as amended, or other statutory authority, or directly by commercial firms to foreign countries, foreign private firms, or to international organizations. See also conventional arms transfers.

Building Partner Capacity (BPC) Programs – Security cooperation and security assistance activities that are funded with U.S. Government appropriations and administered as cases within the FMS infrastructure. These programs provide defense articles and/or services to other U.S. Government departments and agencies under the authority of the Economy Act or other transfer authorities for the purpose of building the capacity of partner nation security forces and enhancing their capability to conduct counterterrorism, counter drug, and/or counterinsurgency operations, or to support U.S. military and stability operations, multilateral peace operations, and other programs.

Defense Security Cooperation Agency – The agency that performs administrative management, program planning, and

operations functions for U.S. military assistance programs at the DoD-level under the policy direction of the Under Secretary of Defense (Policy) (USD(P)).

Foreign Assistance Act (FAA) of 1961 – An act to promote the foreign policy, security, and general welfare of the United States by assisting peoples of the world in their efforts toward economic development and internal and external security, and for other purposes.

Foreign Military Financing (FMF) – FMF provides grant assistance for the acquisition of U.S. defense articles, services, and training that promotes U.S. national security by contributing to regional and global stability; strengthening military support for democratically elected governments; and containing transnational threats, including terrorism and trafficking in narcotics, weapons, and persons. These grants help key allies and partners improve their defense capabilities and foster closer military relationships between the United States and recipient nations. Increased military capabilities strengthen multilateral coalitions with the United States and enhance ally and partner interoperability with U.S., regional, and international military forces. Foreign Military Sales (FMS) – A process, authorized by the Arms Export Control Act, through which eligible foreign governments and international organizations may purchase defense articles, services, and training from the U.S. Government.

Implemented Case – An FMS case that has been signed by an authorized representative of the foreign partner, and for which (1) any required initial deposit has been received by the Defense Finance Accounting Service (DFAS) and deposited; and (2) applicable data system implementing transactions have occurred.

Security Assistance (SA) – A group of programs authorized by federal statutes by which the United States provides defense articles, military training, and other defense-related services by grant, lease, loan, credit, or cash sales in furtherance of national policies and objectives, and those that are funded and authorized through the Department of State to be administered by DoD/DSCA, which are considered part of security cooperation.
