Given that the licenses issued in 2015 can be utilized until the closing of year 2016, this Report covers the process of utilization of licenses until May 2016.

## SECTION ONE

# INTRODUCTION

The Law on Foreign Trade in Weapons, Military Equipment and Dual-Use Goods (“Official Journal of Montenegro” No. 80/08) and the related by-laws provide a basis for the state control of foreign trade in arms, military equipment and dual-use goods (hereinafter referred to as: Controlled Goods).

The legal framework for producing the Annual Report on International transfers of Controlled Goods has been summarized in Article 32, paragraph 1 of the Law on Foreign Trade in Weapons, Military Equipment and Dual-Use Goods (“Official Journal of MNE”, No.80/08). The Ministry of Economy of Montenegro, as the body responsible for the implementation of the Law and related regulations in the area of foreign trade in Controlled Goods, produced this Report.

In addition to the legal framework, the **tenth National Report** providing an overview of the export-import control of Controlled Goods during the year 2015, was produced by the Ministry of Economy in accordance with the recommendations of the international community. In producing this Report, the EU recommendations on the form and content of national reports have been observed in order to make it compatible with the reports of the European Union and useable for comparison with the national reports of neighbouring countries and countries worldwide.

With regards to the selection of data to be published, a compromise has been reached that includes the commitment to publish information while at the same time protecting the commercial interests of business entities. All data are published in an aggregated form in order to maintain the confidentiality of information, in accordance with the Data Confidentiality Act (“Official Journal of MNE”, No. 14/08, 76/09, 41/10, 38/12, 44/12, 14/13,18/14 and 48/15) and Unpublished Data Protection Act (“Official Journal of MNE”, No. 16/07, 73/08).

After the Report has been submitted to the Government and adopted, the Report is published by the Ministry of Economy and posted on the Ministry’s official website [www.mek.gov.me](http://www.mek.gov.me). Thus a higher level of transparency is achieved with regard to these activities, which contributes to building Montenegro’s credibility worldwide and improving international cooperation in this field.

*The Report contains general information on the national control lists, past experience in the field of foreign trade in controlled goods, active participation in workshops/training courses and further advancement of the control system, as well as the analysis of statistical data shown in the Annexes.*

*The Report does not contain information on the Law on Foreign Trade in Controlled Goods, the export/import controls policy, competent institutions in the licensing process, licensing criteria since no amendments have been made compared to the previous Report posted on the official website of the Ministry of Economy.*

*The Annexes also contain tables with figures regarding the approved requests for foreign trade in controlled goods activities.*



## SECTION TWO

# NATIONAL LEGISLATION

1

## National Control List

Article 6 of the Law on Foreign Trade in Weapons, Military Equipment and Dual-Use Goods ("Official Journal of Montenegro", No.80/08) prescribes that upon the request of a ministry in charge of foreign trade activities, the Government shall approve and update the National Control List of Arms and Military Equipment and shall harmonize it with the EU legislation. The EU Lists are evolving documents and are updated on an annual basis; thus it is necessary to regularly update the corresponding National Control List in order to keep up with development and events in the respective international control regimes, and to harmonize with them.

## Other Regulations

In the Montenegrin legislation there are other applicable laws, in addition to the Law on Foreign Trade in Weapons, Military Equipment and Dual-Use Goods and the Law on Dual-Use Export Controls, related to international transfers of controlled goods. They regulate specific issues of importance in the field of foreign trade in controlled goods.<sup>1</sup>

Early in 2015, Montenegro launched the International Control Regime WA accession initiative, while accession to other regimes shall be considered in accordance with its needs and capacities.

## 4

## International Treaties and Conventions

Activities of Montenegro aimed at fulfilling its commitments derived from multilateral agreements on arms control, disarmament and non-proliferation have focused on integration into organizations which provide strong mechanisms of preserving peace and security, whilst respecting the interests of all countries. Along with the establishment of an institutional framework for bilateral and multilateral security cooperation, the relevant authorities are taking the necessary steps in order to lay the relevant legislative foundations, including ratification and implementation of international treaties in the field of disarmament, non-proliferation, arms control, combating terrorism and organized crime.

Montenegro has constantly supported the application of all international instruments regulating the field of disarmament and arms control; it recognizes each new and constructive initiative aimed at building and increasing international cooperation in order to reduce and eliminate risks and consequences of production and use of any weapons and ammunition.

After the declaration of independence, on 3rd June 2006, Montenegro decided to succeed to the treaties which are in accordance with the legal system of Montenegro; thus becoming an active stakeholder in the performance of the major part of international treaties and conventions in the field of disarmament and arms control.

As regards disarmament, non-proliferation and arms control, Montenegro has played an active role in the implementation of a series of other international instruments, as follows: 1999 Vienna Document, 2000 OSCE Document on SALW, 2003 OSCE Document on Stockpiles of Conventional Ammunition, 2004 OSCE Decision on End-User Certificates, 2004 OSCE Principles on the Control of Brokering of Small Arms, 2003 OSCE Elements for Export Controls on Man-Portable Air Defence Systems (MANP ADS), the Formal Doc-

4 The goal of the Zanger Committee is to prevent the diversion of exported nuclear materials for civilian purposes and their development into nuclear weapons or other nuclear devices.

5 This control regime was established in 1985, with the goal of curbing the proliferation of weapons for mass destruction, especially chemical and biological weapons, and equipment for dual-use production. It includes over 40 participating states, some of which are EU member countries.

ument as per Article IV of Annex 1B of the General Framework Agreement for Peace in BiH (Dayton Accords).<sup>7</sup>

In the field of non-proliferation of weapons of mass destruction and combating terrorism, Montenegro has been active in improving the legislative framework for the implementation of the UN Resolutions **1373** and **1540**. Adoption of the 2014-2018 National Action Plan for the Implementation of Resolution 1540 in May 2014 was followed by the establishment of the Coordination Body for the implementation of the Resolution. At the same time, an updated progress Report was produced and submitted to the competent UN Committee.

Montenegro is a signatory of the **Hague Code of Conduct** against Ballistic Missile Proliferation (**HCOC**) and it regularly submits annual reports on the implementation of the Code.

With regard to SALW control, Montenegro implements the **United Nations** Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in all its aspects relying, first of all on the following international documents:

1. United Nations Convention against Transnational Organized Crime and the UN Firearms Protocol against the Illicit Manufacturing of and Trafficking in Firearms, their Parts and Components and Ammunition<sup>8</sup>;
2. United Nations Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All its Aspects;
3. OSCE Plan of Action on Small Arms and Light Weapons (SALW);
4. Regional Micro-Disarmament Standards for South-Eastern Europe (RMDS);

The Government of Montenegro has adopted the **Strategy for Control and Reduction of Small Arms and Light Weapons (SALW), and the 2013-2018 Action Plan**, which define the SALW control activities. In accordance with the commitments provided under the Strategy and Action Plan, a Coordination Body for the Implementation of the Strategy for Control of Small Arms and Light Weapons was set up with the mandate to coordinate and direct the activities of all relevant stakeholders taking part in the implementation of the Strategy, inform the public about the planned activities and results obtained, draft a progress report related to the control and reduction of small arms and light weapons in accordance with the UN Programme of Action to Prevent, Combat and Eradicate the Illicit Trade of SALW and the OSCE Plan of Action on Small Arms and Light Weapons, as well as with other relevant agreements.

<sup>7</sup> **Agreement on Sub-Regional Arms Control** (Article IV, Annex 1-B, Dayton Accords), the Parties of which are the Republic of Serbia, Croatia, Bosnia and Herzegovina and Montenegro, was endorsed on 14th June 1996 in Florence and ranks as one of key and essential mechanisms for peace-keeping and improvement of security and stability in the region. **The goal of the Agreement** is to achieve and maintain balanced and stable defence force levels in the region in terms of reduction of numbers of conventional weapons into five categories (tanks, over 75mm artillery weapons, armoured vehicles, combat aircrafts and assault helicopters) under control of the Parties.

In addition to its membership in international treaties in the field of disarmament and arms control, and with the view to providing support and contributing towards building both regional and European stability and security, Montenegro is conducting a number of activities in accordance with the following international documents:

- 1999 Vienna Document<sup>9</sup>;
- Treaty on Conventional Armed Forces in Europe (CFE), and
- Treaty on Open Skies<sup>10</sup>.

*With regards to the process of foreign trade controls of arms, military equipment and dual-use goods, Montenegro is observing more comprehensive criteria, in comparison to those envisaged by the **Arms Trade Treaty (ATT)**, which Montenegro ratified in July 2014. Having in mind that each contribution to the responsible control of exports, imports and transfers of weapons adds to both regional and global security, Montenegro found itself in the group of the first countries to accede to the International Arms Trade Treaty, thus ratifying the Treaty by adopting the **Law on Ratification of the Arms Trade Treaty** ("Official Journal of Montenegro – International Treaties, No. 9/2014" of 4 August 2014).*

<sup>9</sup> Montenegro regularly fulfils its commitments related to the **1999 Vienna Document**, which include confidence and security building measures, exchange of annual information and controls through evaluation visits to military units, inspection of specific areas, visits to military air bases, observing the announced military activities, observing training and exercises, and by learning about new types of weapons. Montenegro has committed to ensuring three inspections of a specific area and one evaluation visit on an annual basis, while the number of inspections and evaluations accepted on a bilateral level is not limited and it is up to Montenegro to decide.

## SECTION THREE

# MONTENEGRO IN THE FOREIGN TRADE CONTROL SYSTEM

Compliance with standards in the area of control of arms, military equipment and dual-use goods foreign trade, which are observed by all countries united in the fight against international terrorism and proliferation of weapons of mass destruction (WMD), is of outmost importance for the inclusion of Montenegro in the international export control system and accession to international control regimes and agreements in this area.

## International Cooperation

In the course of 2015, and pursuant to the EU Council Decision **2015/2309/CFSP - whereby the EU has decided to continue and expand its activities**, the Ministry of Economy continued its fruitful cooperation with international organizations and institutions responsible for export controls of arms and military equipment. Such cooperation highly contributed towards gaining new knowledge and experience, which resulted in higher efficiency of activities of export control of controlled goods.

## Technical Support for Capacity Building in Montenegro in the Field of Controlled Goods Foreign Trade Controls

In order to strengthen capacity of institutions and increase the efficiency of the foreign trade control system, passing and enforcement of legislation in this area, a very fruitful international cooperation took place over the last couple of years. In the course of 2015, representatives from the Ministry of Economy and other institutions involved in the control system took part in the following workshops and conferences:

## **Further Activities in the Field of Foreign Trade Controls of Controlled Goods**

In order to improve the foreign trade control system regarding controlled goods, which is one of the priorities of the Ministry of Economy, the assistance of international community continues to be necessary together with strengthening of inter-agency cooperation in the field of law enforcement, as well as the outreach to the industry in this field.

Consequently, in order to further improve the export-import control system, it is necessary to:

- Continue with the process of development and full implementation of the legal regulations and of the present system of arms, military equipment and dual-use goods export control;
- Strengthen regional cooperation in the field of export control;
- Establish new National Control Lists, or else harmonize them with the lists adopted by the EU;
- Fulfil all the commitments derived from the membership of Montenegro in the UN, together with numerous resolutions, recommendations and other documents in the field of combating proliferation of weapons of mass destruction and terrorism;
- Hold seminars and training courses for local industry and the governmental sector on foreign trade control of controlled goods;
- Improve the technical base and education of Customs Authorities in order to train them to combat the trafficking of controlled goods;
- Continue participating in the EU Long-term Project<sup>11</sup>.

## SECTION FOUR

# STATISTICAL OVERVIEW

From the moment the Law on Foreign Trade in Weapons, Military Equipment and Dual-Use Goods was enforced, until the moment when this report was finalized by the Ministry of Economy, thirty-nine (39) companies were entered in the Register of entities that may perform foreign trade in weapons, military equipment and dual-use goods, while thirteen (13) companies did not renew their registration.



**Annex 1/15:****Data on Issued Export Licences for Arms and Military Equipment (AME)**

In 2015, the Ministry of Economy, issued a total of **64** export licences for **23** destinations, in the total value of **€ 11.31 million**. The entire value of export licences issued in 2015 was **higher** by **€ 0.31 million** or 2.74% than the value of exports approved in 2014. The approved exports in 2015 exceeded the export in the period of 2013; 2012; 2011; 2010, and 2009 by: **€ 4.85 million; € 6.39 million; € 7.35 million; € 1.38 million, and € 3.59 million, respectively** (see **Graph No.1**).

**According to the number of issued licences,** the following destinations were the most important: **Poland (8); Serbia, Bulgaria and Ukraine (7 each); Saudi Arabia (5), Malaysia (4); USA and Bangladesh (3 each); Indonesia, Iraq, Pakistan and United Arab Emirates (2 each).** Fifty-two (52) licences for export of AME or 81.25% were issued to these 11 destinations.


In the process of AME export, companies from 6 countries acted as brokers (buyers) through which goods were delivered to the end-users, as follows: Republic of Serbia, Cyprus, Switzerland, Republic of Slovakia, Singapore and Panama.

**In terms of value,** the most important export destinations were: **Bangladesh (€ 3.03 million), Saudi Arabia (€ 2.79 million), Poland (€ 1.26 million), Malaysia (€ 1.19 million), Serbia (€ 0.71 million), Ukraine (€ 0.49 million), Slovakia (€ 0.37 million), Bulgaria (€ 0.33 million)** (see **Graph No. 2**).

The total value of AME exports, as per licences issued for 8 most important destinations, amounted to **€ 10.17 million**, which makes up **85.4%** of the value of AME export licences issued in 2015.

Detailed information about the approved quantities of AME for export and their respective values is provided in **Annex 1a/15** of the Report.

**Graph No. 2.** Exports of arms and military equipment broken down by destinations (in million €)



**Graph No. 3** shows the structure of approved export licences in 2015. It demonstrates that the goods that were most exported are those belonging to the category ML3, followed by the categories ML10, ML1, NL8. In other words, the structure of the exported goods included products listed under 4 control numbers of the National Control List of Arms and Military Equipment in the value of **€ 9.09 million**, or 80.4% of the total approved export in 2015.

**Note:** The definition of certain AME categories classified in groups has been given in **Appendix 1** of this Report.


**Graph No. 3.** Structure of exports of arms and military equipment in 2015 (in million €)



**Annex 2/15:****Data on Issued Import Licences for Arms and Military Equipment (AME)**

In 2015, the Ministry of Economy issued a total of **54** import licences from **16** destinations, in the total value of **€ 17.83 million**. The entire value of the issued import licences in 2015 exceeded the value reported in 2014, 2013, 2012; 2011; 2010, and 2009 by: **€ 11.26 million; € 13.24 million; € 13.3 million; € 12.49 million; € 3.04 million**, and **€ 10.16 million**, respectively. This means that the value of approved import licences is higher in comparison to the previous years. (**Graph No. 4**).

**According to the number of issued licences**, the following destinations were the most important: **Serbia (16), BiH (11), Czech Republic, (5), USA and Slovenia (3 each), Austria, Israel, China, Macedonia and Germany (2 each)**.

Forty-eight 48 licences for export of AME or 88.9% were issued to all these destinations.


**In terms of value**, the most important import destinations were: **Israel** (€ 11.84 million), **Czech Republic** (€ 2.27 million), **BiH** (€ 1.18 million), **Serbia** (€ 0.88 million), **Slovenia** (€ 0.54 million), **China** (€ 0.37 million), (see **Graph No. 5**).

The total value of AME imports, as per licences issued for the first 6 destinations amounted to **€ 17.08 million**, which makes up **96%** of the value of AME import licences issued in 2015.



**Graph No. 6** shows the distribution of approved import licences in 2015. The most imported goods fall under the ML1 category – in the total value of **€ 10.06 million** or 56.5%; followed by ML3 – **€ 4.18 million** or 23.5%; ML4 - **€2.02 million** or 11.3%, which make up 91.3% of total approved imports.

Import of goods belonging to ML1 category actually represents import of goods for the purpose of deconservation, degreasing which is performed in the Port of Bar Free Zone, with the aim of selling the aforementioned goods.

**Annex 3/15:****Data on issued Export Licences for Non-Military Munitions**


In 2015, the Ministry of Economy issued **7** export licences for **4** destinations, in the total value of **€ 1.41 million**. The value of approved export licences in 2015 is by **€ 0.6 million lower** than the value of licences approved in 2014, and by **€ 0.1 million higher** in comparison to 2013, i.e. by € 1.14 million compared to 2012 (see **Graph No. 7**).

The most important export destination is Kosovo, **€ 0.69 million**; BiH, **€ 0.55 million**, which makes up 87.9% of the total approved exports. The share of the other two destinations in the overall approved export is only 11.1%.

The structure of the approved exports of non-military munitions is shown in detail in Annex 4a/15 of this Report.

**Note:** The definitions of specific non-military munitions have been provided in the Appendix 2 of this Report.

(in million €)




## Annex 4/15:

### Data on Issued Import Licences for Non-Military Munitions (NUS)

In 2015, **51 licences** for import of non-military munitions from 11 destinations were issued in the total value of **€ 23.02 million**. Compared to 2014, the total value of approved imports is higher by **€17.49 million**, and by **€18.07 million higher** as compared to 2013, and by **€18.55 million higher** in comparison to 2012 (see **Graph No. 8**).

According to the number of issued licences, the most important destinations were: **Serbia (11), BiH (8), Germany and Turkey (7 each), Italy (6), Croatia (5), Slovenia (3)**, or 92.2% of the approved licences.

(in million €)




The major share of the approved imports of non-military munitions was from BiH in the value of **€ 12.9 million** or 58.6%, followed by Turkey, in the value of **€ 4.41 million**, or 20% of the total approved import, followed by Serbia with **€ 2.13 million** or 1%, etc. (see Annex 5a/15).

The structure of the approved exports of non-military munitions has been presented in Graph No. 9. The major part of imports was approved for the goods under the non-military munitions category **2.6** - €10.83 million or 37%, **category 2.1.** - €4.47 million or 19.42%, **category 1.4.** - €2.41 million or 10.47%, **category 2.4.** - € 2.31 million or 10%, **category 1.1.** - €1.67 million or 7.25%. The value of imports of the indicated goods amounts to € 21.69 million or 94.2% of the total approved imports (see **Graph No. 9**).

Detailed structure of imports of non-military munitions has been shown in Annex 5a/15. The percentage of licences used until the moment of production of this report in relation to total approved imports is only **€ 0.44 million** or **1.9%**.

**Graph No.9.** Structure of approved import of non-military munitions for (in million €)




#### Annex 5/15:

##### Data on issued Licences for Brokering activities

With the entry into force of the Law on Foreign Trade in Controlled Goods, the control of brokering activities was regulated<sup>13</sup>.

In **2015**, the Ministry of Economy issued a total of **11 licences** for brokering activities, in the total value of **€ 2.38 million**. The value of the issued brokering licences was by **€ 2.35 million** or 50.31% lower than those issued in 2014. In comparison to 2013, the approved brokering activities were lower by **€ 7.56 million**. If compared to the values of brokering licences in the previous years (2012, 2011 and 2009), it can be concluded that in 2015, the value of approved brokering activities was lower (see **Graph No. 10**).


**Graph No. 10.** Approved brokering activities in 2009/2010/2011/2012/2013/2014/2015 (in million €)


In 2015, most brokering activities were approved for AME (ML3 - **€ 0.97 million** or 40.7% and ML4 - **€ 0.84 million** or 35.3%), (see **Graph No. 11**).

The highest value of approved brokering activities in 2015, was related to the export of goods from the Republic of Serbia to Philippines as the end-user, in the amount of **€ 0.97 million** or 40.7%, India - Albania € **0.36 million** or 15.12%. Republic of Serbia to Israel as the end-user in the amount of **€ 0.32 million** or 13.4%, and Serbia - Indonesia and BiH - SA in the amount of € 0.28 million or 11.8% of approved brokering activities. The approved brokering activities at these destinations amount to **€ 2.21 million** or 92.85% of the total approved value (see **Graph No. 12**).

The value of brokering activities amounts to **€ 0.39 million** or 16.4%. (For more details see Annex 5a/15).

## **Annex 6/15:**

### **Data on Issued Export Licences for Technical Assistance**

In 2015, one export license was issued for the provision of technical assistance in the amount of **€ 1.34 million** in Bangladesh. The said technical assistance related to the technology and knowledge transfer.

## **Annex 7/15:**

### **Data on Issued Import Licences for Technical Assistance**

In 2015, three license were granted for the import of technical assistance in the amount of **€ 0.03 million**. These services were related to the repair of helicopters of the Ministry of Defence of Montenegro and testing of gunpowder chemical stability.

## **Annex 8/15:**

### **Information on Denied Applications for Export/Import of Controlled Goods**

In the course of 2015, a total of **191 licences were issued**, which is by 9 higher than in 2014.

In the aforementioned period, due to negative approval of competent ministries, the Ministry of Economy denied **eight (8)** licencing application for exports of AME in: Ukraine, Iraq, Libya, Saudi Arabia, Bulgaria, Algeria, Afghanistan and Vietnam. The total value of denied licencing applications amounted to **€ 1.84 million**. During this period, the companies cancelled the activity and returned three issued licenses, as follows: one licence for the Republic of Gabon, and two licences for Saudi Arabia. The total value of licences on the basis of which the companies cancelled the activity, amounted to **€ 0.17 million**.

As regards the import of AME in 2015, the Ministry of Economy denied **three (3)** licencing applications for the import of the said goods from the Republic of Serbia, Iraq and Israel. The foreseen value of the planned activities amounted to **€ 2.34 million**.

In 2015, based on the legally defined criteria for obtaining a license, the Ministry of Economy denied a licensing application for the provision of brokering activities – Sender: India – End-User: Albania. The estimated value of the transaction amounted to **€ 0.55 million**.

Furthermore, **two (2)** licencing applications for the import of non-military munitions from Croatia, in the amount of **€1.46 million** were denied in 2015.

## APPENDIX 2

#### LNM 2 “Energetic materials”, and related substances, as follows:

- 2.1.** “Explosives” and their compounds;
- 2.2.** Propellants (gunpowder);
- 2.4.** Prepared explosives, except for gunpowder;
- 2.5.** Safety fuzes and detonating fuzes;
- 2.6.** Percussion and explosive caps; fuzes; electric and non-electric detonators;
