^a 'Publicly listed' means that the company's shares were publicly traded on a stock exchange of its home country, with no single majority shareholder. 'Privately owned' means the company was owned by one or more private shareholders, with its shares not traded on any stock exchange.

^b In cases where the deal value is not available in US dollars, currency conversion has been made using the International Monetary Fund average exchange rate for the calendar month in which the transaction was made. Companies do not always disclose the values of transactions.

^c Where deal values are not known, the acquired company's annual revenue is listed where known (either actual revenue for 2007 or expected revenue for 2008 or 2009). Where revenue is not available in US dollars, currency conversion has been made using the International Monetary Fund average exchange

rate for the appropriate year. Where information is not available for either the deal value or the acquired company's revenue, the acquired company's number of employees is shown, where known. Within each regional category, acquisitions are listed first in order of deal size where known, then in order of the acquired company's revenue where known. Where only employee numbers are known, the acquisitions are listed according to a conservative estimate of the likely range of revenues of the acquired company.

^d Although in this case both the buyer and seller companies are from the UK, this is classified as a transatlantic deal because the acquired operations are in the USA. It is therefore an acquisition of US-based operations by a European company.

^e Although in this case both buyer and seller companies are from the USA, this is classified as a transatlantic deal because the acquired operations are based in Europe (the UK). It is therefore the acquisition of European operations by a North American company.

^f An agreement was reached on 19 Dec. 2008 for Dassault Aviation to acquire the 20.76% stake held in Thales by Alcatel-Lucent. Another 5.16% of Thales's shares are held by Dassault Aviation's parent company, Groupe Dassault. It is understood that Dassault Aviation will acquire this stake as well, for a total stake of 25.93%. Another 27.05% of Thales's shares are held by the French Government or companies owned by the French Government. The remaining shares are publicly traded.
